Helping families access affordable, quality child care

Your gift to the Child Care Fund supports United Way partners that provide quality child care services to low-income children under the age of 12 in Larimer County. At the core of a family's ability to be successful is their ability to maintain a good job and having access to affordable, quality child care significantly increases their ability to do so. In addition to supporting youth and families, gifts are eligible for the Colorado Child Care Contribution Credit that provides standard Federal and State income tax deductions as well as a 50 percent state tax credit.

OTHER NONPROFIT ORGANIZATIONS

The choice is yours

You can make designations to most U.S. 501(c)(3) public charities, including most churches, university foundations and service organizations, for exclusively charitable purposes, at the time you make your pledge/contribution. PHILANTHROPY FUND

When the time is right

If you are not prepared to designate a charitable recipient at the time you make your pledge/contributions, you may establish a Philanthropy Fund to temporarily hold undesignated gifts for a limited time. You can then make distribution recommendations throughout the year. To best serve individuals and families in need, amounts in a Philanthropy Fund must be distributed by June 30th of the fiscal year following the fiscal year in which you give.
