LARIMER COUNTY CHILD CARE FUND

supports programs and partners that provide child care services to underserved children under the age of 12. Gifts of \$250+ qualify for the Colorado Child Care Tax Credit (CCCTC), a 50% state tax credit.

NONPROFIT EXCELLENCE

provides Larimer County nonprofits access to trainings and professional development, as well as high-quality back-end services like human resources and grant writing.

COLORADO READING CORPS

a nationally replicated model that utilizes AmeriCorps Members, trained in early intervention literacy strategies, to provide one-on-one tutoring to kindergarten through third-grade students who are not reading at grade level.

WOMEN GIVE

provides support and financial assistance in the form of child care scholarships to single mothers pursuing higher education and establishing financial stability in Larimer County.

WHAT YOUR DOLLARS CAN DO

Based on an annual gift over 26 pay periods

\$5 per pay period can provide five nights in a shelter to help a local family find stable housing.

Why it matters: 36,000 Larimer County residents live in poverty, including 9% of children under age 18 and 7% of residents age 65+.

\$20 per pay period can provide a local family with scholarships for quality, affordable child care.

Why it matters: 90% of brain development occurs by age five, and kindergarten readiness is a key indicator of life long academic success.

\$10 per pay period can provide one-on-one after-school mentoring for a local student to improve their grades.

Why it matters: 16% of Larimer County students don't graduate on time. Mentoring is a proven way for kids to improve their grades.

\$50 per pay period can provide 3 hours of job training for 12 adults to increase their income and self-sufficiency.

Why it matters: Only 47.7% of jobs in Larimer County could sustain a family of four.
